Non-winning entries will carry forward into subsequent Entry Period drawings. The Administrator's computer is the Sweepstakes official clock.

2. ELIGIBILITY: This Sweepstakes is offered only to legal U.S. residents of Alabama, Florida, Georgia, Louisiana, Mississippi, North Carolina, and South Carolina who are at least eighteen (18) years old at the time of entry.
